GENERAL DESCRIPTION

The regular formed beet leaves portions are prepared from fresh, sound, healthy, good washed beet leaves of the genus Beta Vulgaris L.cv. cicla L.

Cut size: 13-15mm

REQUIRES AT THE FROZEN PRODUCT

- colour: typical for young, fresh beet leaves.
- flavour and odour : typical for young, fresh beet leaves. No off-flavour and off- odour allowed.

DEFINITION OF DEFECTS ON RAW MATERIAL

- a) Leaf/ Stems
- b) F.M. : not vegetable material such as wood, glass, stones, insects, etc
- c) F.E.V.M. : this includes any vegetable matter not derived from the beet leaves plant, and which is non-toxic.
- d) Damage by insects or disease (rotten).
- e) Root pieces
- f) Yellow/ brown leaves
